Funding approved for the Upgrade of the Play Park in Potterhanworth

The Parish Council Potterhanworth had applied to FCC Communities Foundation for a project called "Potter on the Move– A play park for everyone." The money, will be used to install play and fitness equipment at the Play Park next to the Pavilion in Potterhanworth.

- (4) provide accessibility for people with prams, dogs and wheelchairs;
- (5) contribute towards the social cohesion of the village.
